

Privacy statement

PERSONAL DATA THAT WILL BE PROCESSED

Interteach B.V. can process personal data about you, as a result of you using the services provided by Interteach B.V. and/or because you provide these details to Interteach B.V. when completing a contact form on the website. Interteach B.V. can process the following personal data:

- Your first name - and surname
- Your address details
- Your telephone number
- Your date of birth
- Your gender
- Your e-mail address
- Your IP address

WHY DOES INTERTEACH B.V. NEED YOUR DATA?

Interteach B.V. processes your personal data in order to offer relevant services and to contact you at your request and/or to send you written information (by e-mail and/or by post) if we are unable to contact you by telephone.

FOR WHAT LENGTH OF TIME DOES INTERTEACH B.V. STORE DATA?

Interteach B.V. will not store your personal data for any longer than strictly necessary to achieve the objectives for which your data were collected. Your data will not be stored for any longer than one year if this contact does not result in any agreement.

SHARING WITH OTHERS

Interteach B.V. will only share your personal data with third parties if this is necessary for the fulfilment of an agreement, to meet legal obligations, or for back-ups of personal data that are stored in encoded formate on Dropbox servers.

LOGGING OF WEBSITE VISIT

The Interteach B.V. website logs general visitor data, including the IP address of your computer and the time of request and information transmitted by your browser. These data can be used for analyses of visits and click behaviour on the website. Interteach B.V. uses this information to improve the functioning of the website. These data will be made anonymous wherever possible and will not be supplied to third parties.

GOOGLE ANALYTICS

Interteach B.V. uses Google Analytics to track how users navigate the website and how effectively the Adwords advertisements for Interteach B.V. are on the Google search results pages.

The information obtained in this manner, including the address of your computer (IP address), will be transmitted to and saved on servers in the United States by Google. Please read the Google privacy policy for more information.

Google will use this information to keep track of how our website is used, to give Interteach B.V. reports about the Website and to offer its advertisers information about the efficacy of their campaigns. Google can supply this information to third parties if Google is legally required to do so, or insofar as these third parties process the information on behalf of Google. COOKIES

This profile is not linked to your name, address, e-mail address or similar, but is used to ensure that advertisements match your profile so that they are as relevant as possible to you.
